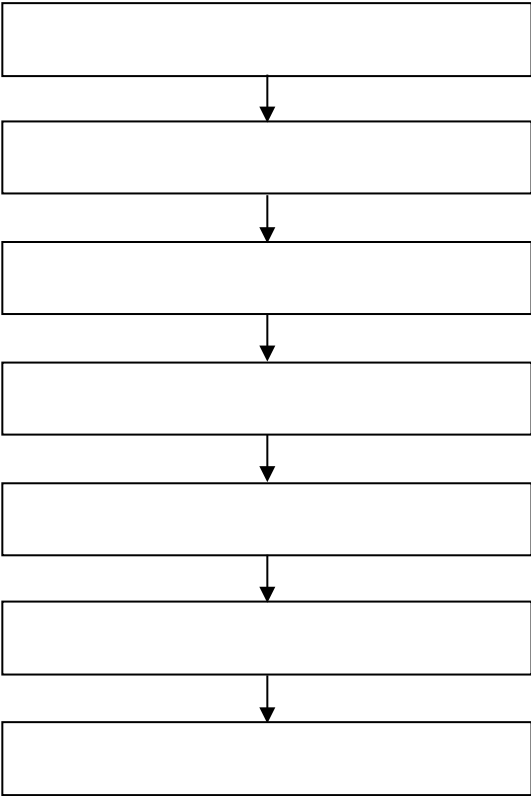

PFASs/ PFOS/PFOA Testing Flow Chart



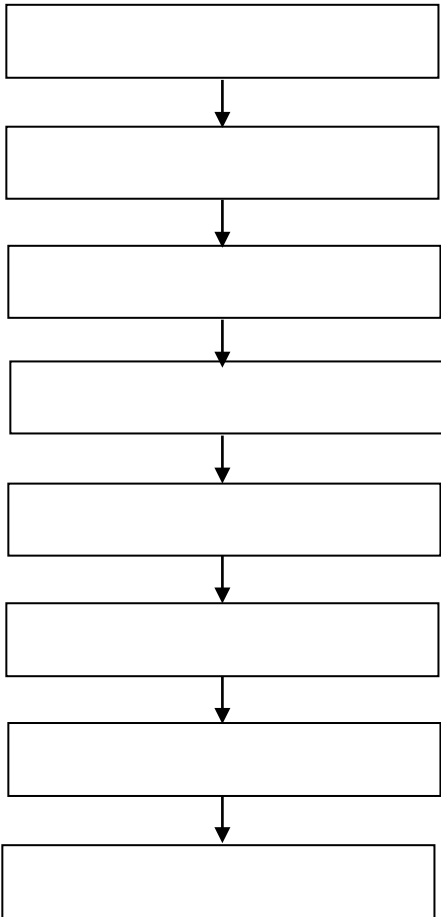

Chlorinated Paraffin Testing Flow Chart



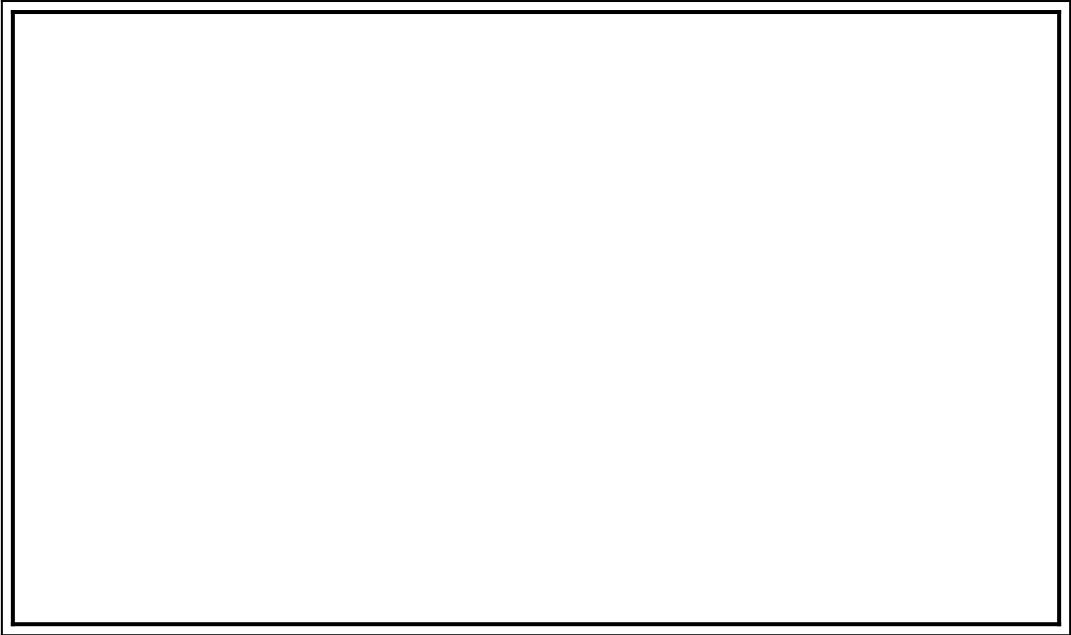
